<u>PUBLIC ADDRESS TO COUNCILLORS, FEEDBACK FROM COUNCIL SURGERY and OTHER SOURCES</u> - (Items raised are discussed by Councillors under related entries on Agenda).

- Request to change Village Status from Local Centre back to a Village, due to lack of amenities now. Action/Resolution: Dover District Council working towards the new Local Plan, anticipated to be out for consultation in July 2019. As per evidence received from recent questionnaire, indication is residents wished this. Cllrs: Norris and Pilcher would be meeting with Dover District Council Officer to discuss further.

- ER252 (New Dover Road to Capel Street), works to be carried out are part of Planning Application for Jarvis Homes and the Unilateral Undertaking to pay for improvements for the Community. Cllr. Lake had been in communication with the PROW Officer. Action/Resolution: Message from David Fleck, KCC PROW Officer The works on Bridleway ER252 have been postponed while Kent PROW obtain an ecological survey on the area. The British Horse Society has been involved in discussions on this project and the substrate will be modified in accord with their recommendations for path surfacing where possible. The trees and vegetation due to be removed will be subject to the ecological survey and widths varied accordingly. These works are to benefit all users of this Bridleway which are not exclusively for Horse riders and include wheelchair users, cyclists and children attending the local school.

j) District Councillor Frederick Scales

- Restoration reported at Kearsney Abbey/Russell Gardens with new footbridge, footways and terraces.
- Successful conviction of fly-tipping reported.

County Councillor Geoff Lymer

- A reorganisation of stroke services across Kent has been given the go ahead following a five year
 review. The County's six acute stroke units are to be replaced with three specialist hyper-acute
 stroke units, following a decision by the Joint Committee of Clinical Commissioning Groups.
- KCC has approved a council tax increase of 4.99% for the 2019/20 budget. This increase is needed to help meet a shortfall of more than £80 million, caused by the high demand on front line services, such as adult social care, special educational needs children, public health, however, this does not include Kent Highways whose annual budget is a meagre £3 million.
- KCC has reviewed the Young Persons Travel Pass and whilst I must stress this is a privilege and
 not a right, for few other Counties operate such a scheme now. However, KCC is mindful this is of
 immense benefit to those on low incomes and to acknowledge this, KCC has decided to instigate a
 payment plan by instalments, rather than expect a one of payment.
- Central Government has commissioned a review on the planning application appeals. It found the
 average time for appeals took 47 weeks. The Government is committed reducing this period to 26
 weeks. The Committee secretary James Brokenshire stated speeding up decisions could help the
 government realise its target of 300 thousand homes a year by the mid-2020s.
