#### Present:

- 1. <u>APOLOGIES</u> Cllrs; Leppard, Pilcher, Shaw and Tutt and County Councillor Geoff Lymer.
- 2. The meeting welcomed Jayne Cribben from the Thanet Community Bus Scheme, who explained services that could be available for residents, which included a Dial-Up service (Membership £5 per annum and £3.50 per trip). Councillors enquired about a regular route service via Blackbull Road. Action/Resolution: This would be investigated further by the Company. Capel Cares to hand out leaflets and invite Jayne to their next coffee morning with bus.

# 3. PUBLIC ADDRESS TO COUNCILLORS, FEEDBACK FROM COUNCIL SURGERY and OTHER SOURCES

- Concerns were expressed by some members of public present on the issues at the Farmers Market with a stallholder. Action/Resolution: Cllr. #### **Applications waiting Parish Council Decision**

 18/00585 Proposal: Scoping Opinion - Environmental Impact Assessment (updated) Location: Site at Western Heights & Farthingloe, Dover, CT17 9DX Action/Resolution:

Whilst Capel-le-Ferne Parish Council support the regeneration of the Western Heights, we are concerned about the number of dwellings proposed in the picturesque area of Farthingloe. There will be an impact on the volume of traffic on the B2011 through Capel-le-Ferne, which will tender to further sever the village into two halves.

Capel-le-Ferne Parish Council agree with the comments made by Kent Highways for a need to rescope a Transport Assessment and Highways England should also be asked for their comments. The original traffic counts from July 2010 are out of date, as is the census data used from 2001. The Dover Strategic Transport Model has also been updated and there have been further developments committed/completed (e.g. St James) which need to be taken into account.
