HELD ON 18th AUGUST 2015

- Petanque equipment storage container request – following discussion agreed it may present a Health and Safety issue. Resident to be informed. *Action: Clerk.*

4. **STATEMENTS FROM (3) CANDIDATES FOR THE (3) CASUAL VACANCIES**

Summaries:

- a) Cherry Leppard: Items of interest in village; litter and fly-tipping. Willing to take responsibility for and/or take on any role.
- b) Lyn Ratcliff: Served on another Council in charge of play equipment. Interested in speeding and planning/building/developments. Lived 11 years in village.
- c) Viv Hale: Community spirited and links. Interested in communication with village, speeding drivers and quad bikes, planning of large houses, traffic calming B2011, pathway Cauldham Lane/Capel Street.

Chairman thanked candidates and informed meeting, discussions and decision to be made at end of meeting.

5. **MINUTES**

The Minutes of the meeting held on 21st July 2015 were proposed as a true record by Cllr. Greening and seconded by Cllr. Tutt and approved. Signed by the Chairman, Cllr. Pilcher.

6. **MATTERS ARISING NOT COVERED ELSEWHERE ON AGENDA**

Chairman decided that firstly the four (4) planters at Courtwood Roundabout would be discussed.

Comments raised - Summary

- i. Earth in front of gate had been placed there by Farmer, who would be building a bund on roadside (Dover Bound) to prevent HGV parking.
- ii. Concrete planters in place (Folkestone bound), require painting and planting. Although there was a question on who would carry this out and maintain them, as it appeared no decision had been agreed. It was noted they were in Hougham Parish Council area, who should be approach out of courtesy.
- iii. The future of the planters should be part of the Council's priority list for the village and cost etc., needs to be investigated for this purpose. Liabilities on painting and maintenance, from a Highway perspective, requires further advice.
- iv. Implications on correct procedure to follow was discussed and agreed requests from both sides should be in writing for clarification.

In order to progress this issue further it was decided to write a letter to County Councillor Lymer and to also arrange an on-site meeting with Highway representative, Hougham Parish Council and Capel-le-Ferne Parish Council representatives to ascertain next stage. *Action: Cllr. K Pilcher & Clerk*

a) **Open Space Needs – New Developments**

Cllr: Pilcher had attend a Village Hall Management Committee meeting to discuss viability and feasibility of working together to provide public toilet facilities and gave feedback. As there was a time scale involved to notify Dover District Council of decision, it was agreed to look at other possibilities than previously discussed, owing to various apprehensions on these facilities. Other future projects discussed, together with amount of funding that could be available, which would be equated and based on statistics. The following were agreed as those recognised and would be put forwarded to Development Officer at District Council for consideration:

Brian Williams on St Mary's Churchyard: "Update on the position regarding St Mary's Churchyard: Following discussions with the insurers and the Diocese, it was agreed earlier this year that those parts of the churchyard that are visited most frequently will be close mown while those areas where graves are visited less frequently will be managed for wildlife, and the grass cut less frequently. Signage is likely to be introduced asking visitors to keep to those areas which are close mown, and to the paths. As I believe I may have indicated in a previous email, this represents a significant departure from the policy that our insurers had been pursuing. A management plan for the churchyard is in the process of being prepared in the light of all this. We have noted the kind offer of members of the Parish Council for assistance in applying for grants should this be necessary, which had prompted our approach to the Parish Council for help in meeting their requirements".
