- n) <u>Traffic Management</u> Consultations with Kent Police and Kent Highways with Councillors to take forward a "Traffic Calming Project" in the Village. Kent Police Dover Inspector and PSCOs agreed to endeavour to undertake more speed checks and Kent Highways are providing the Parish Council with costs on installing marked roundels on the highway, in order to allocate PC funds wisely. These markings will be reminders/repeaters, indicating to drivers the speed limit zone they are travelling in. Other traffic calming measures were discussed at great length and both professional outside agencies agreed and favour highway roundels as the most effective form of measure to take. Flashing signs was also another preferred option, which may form the agenda in future depending on funds available and when the B2011 speed limit zones have been moved accordingly. Action/Resolution: Councillors agreed, initially, to allocate funds towards this Project.

# **Public Spaces Protection Order 2018 – Dogs on Leads**

As discussed we have recently finished a public consultation on varying our 2018 PSPO.

I understand you have been asked to enquire as to whether a dogs on lead requirement could be considered under our PSPO at Capel recreation ground off Lancaster Avenue.

Our existing PSPO is not due to expire until July 2021 so we had not been looking to vary it again until its expiry. Leading up to its expiry we will look to email all parish councils before going to public consultation again to ensure that we have considered all pieces of land where dog restrictions may be required.

It is possible to amend a PSPO during its three year period however we have only just hosted a consultation on varying the 2018 PSPO and the results of consultation are due to be put to council cabinet in the near future..

I would also advise that a dogs on lead requirement at Capel recreation ground would not be in keeping with the rest of the recreation grounds across the district so would be unlikely to be included in our recommendations for a renewed PSPO at present.

Should fouling be a problem I would encourage your councillors to contact my team so we can task enforcement officers to conduct patrols in this area and take enforcement action when offences are witnessed. Patrols can be requested by completing one of our online reporting forms on our website or by clicking on the following weblink:

#### Dear Andrzej

Although dog fouling is an on-going problem at the Lancaster Road recreation ground the reason

For requesting an amendment to the PSPO is due to a safety concern.

This recreation ground is not fenced unlike many recreation grounds in the district. On numerous occasions dogs off leads have been seen to run uncontrolled out of the recreation ground straight across the road in front of cars.

I am sure you will share the communities concerns over safety not only to the dogs but also members of the public. We are asking that this is treated as a special case and that a solution is proposed prior to the next review in 2021.
