Continue to do traffic count when possible. Data from Kent Police is not available Speeding issues still a concern for Councillors on B2011, Old Dover Road and Capel Street and will continue to be pursued on ways to eliminate and educate drivers to keep to the speed zone limits.

- B2011 relocation 40mph and Old Dover Road 30mph signs.
   Disappointment expressed on response letter sent from Kent County Councillor Cabinet Member for Planning, Highways etc., to our MP, following campaign by Parish/District/County Councillors to have the 40mph signage on B2011 (Dover end) relocated nearer to Courtwood Roundabout.
   Relocation of 40mph zone to bottom of Dover Hill (Folkestone end of B2011) being investigated further with Shepway MP and Folkestone Town Council.
- Accidents on B2011 making a safer road None reported
- b) Sunday, 11th November 2018
- c) 1914-1918 Nation's Tribute 100 years Remembrance Councillors discussed next year's 100<sup>th</sup> Anniversary of the end of World War 1, alongside a ceremony to commemorate this special date.

  Crocheted Poppies on Memorial Plinth. Several residents have started to crochet or knit poppies for display on the Memorial Plinth in Lancaster Avenue. # **Applications waiting Parish Council Decision**

- 17/01324, Erection of dormer roof extensions to front and side roof slopes, 28 Helena Road, Capel-le-Ferne, CT18 7LQ
- 17/01190, Erection of a single storey rear extension, rear dormer roof extension with Juliette balcony and 2 front roof lights and replace existing brickwork to all elevations, 145 Capel Street, Capel-le-Ferne, CT18 7HA

Action: Capel-le-Ferne Parish Council feel unable to comment on the plans submitted with this application, due to the confusion that the plans presented, do not reflect the existing. Assuming this is a retrospective application. The plans show the front roof lights to exist already, are they being replaced or is this an error on the drawings? If permitted, it would appear to be the only bungalow on this part of Capel Street with a dormer extension, which can be seen from the rear gardens of neighbouring properties and could create overlooking issues.
