#### 4. <u>MINUTES</u>

#### 5. MATTERS ARISING NOT COVERED ELSEWHERE ON AGENDA

- *a)* <u>New Litter Bin, Winehouse Lane</u> Installed but located in wrong location. Farmer has no objection to its position. Item closed.
- *b)* <u>Battle of Britain Memorial Trust Bus Shelter</u> Shelter ordered and paid for. Additional cost due to moving sign post. Letter received from Stagecoach as a response to letter sent from Chairman. Bus shelter to be installed 17<sup>th</sup>/18<sup>th</sup> December. *Action: Cllr. Pilcher to reply to Stagecoach.*

#### 6. **DELEGATES REPORTS**

- a) <u>Neighbourhood Watch</u> Community Warden/PCSO and/or Cllr. Shaw.
  - *i*. Meeting noted notification that Paul James had left Kent Council Council and had now moved on to a new career as a Licencing Officer for Shepway District Council. Thanks expressed for his devotion to the village and wished him and his family well for the future.
  - *ii.* Cllr. Stone will be supporting Cllr. Shaw to organise a NHW meeting in February for all to attend.
  - *iii*. Cllr. Shaw reported a NHW sign had fallen off a lamp post opposite Capel Court Caravan Park and required re-fitting. *Action: Cllr. Pilcher to refit.*
- b) <u>Play Equipment Status</u> Cllr. Pilcher.
  - *i*. Status report circulated to Councillors. Noted.
  - *ii.* Cross Trainer parts to be replaced by TGOGC in December when next maintenance visit is due.
  - *iii.* Chains on swings to be replaced. Waiting a quote from Wicksteed.
- c) <u>Village Hall Management Committee</u> VHMC Minutes/Cllr. Stone.
- Nothing to report. Annual General Meeting due next week.
- d) <u>Highways</u> Cllr. Tutt.
  - *i.* Kent Highways reported no funding available for major work, only minor works would be considered.
  - *ii.* Caretakers required for a new "Caretaker Scheme", to check drains, cut hedges etc. No funding available.
  - iii. Highway survey will be completed by 27th November. Action: Cllr. Tutt.
  - *iv.* Black and white verge bollards to be replaced outside school and between 94 and 96 Capel Street.
  - v. Footpaths New Dover Road Email from Kent Highways: A section of footpath being replaced on South side with weed spraying. North side, weeds being removed, sprayed and continual monitoring with further attention hopeful for later to this section.
  - *vi.* More planters anticipated at Courtwood Roundabout. Drainage issue believed to be resolved. *Action: To be monitored.*
  - vii. Cattle Sign to be installed at Hockley Sole. Action: Farmer monitoring.
  - *viii.* Battle of Britain require more "dog signs". *Action: Trust will be liaising with Dover District Council.*
  - *ix.* Kevin Bown (Highways England) had offered to attend Parish Council meeting to further discuss TAP on A20 and other Highway/Traffic issues. This was agreed. *Action: Clerk to attempt to make arrangements for December meeting and to invite Hougham Parish Council representative when date confirmed.*
  - x. 20mph Zone in Capel Street and other areas still pending Kent County Council decision.
  - *xi*. Operation Stack issues nothing further to report.

## Councillor Lymer:

- Mental Health in relation to attempting to return people to the work place who have been long term i. sick or disabled, who are of working age still, under the more strict Work Capability Assessment. A study carried out by Oxford and one other university has shown that the new "fit for work" assessment could actually be more harmful under mental health in that 279,000 more cases have been reported under mental health of which there were 590 suicides reported. This situation is therefore being monitored.
- ii. KCC is keen to ensure that all children from 0-5 years have the best start in life, to avoid the types of diseases that can occur often through poor parenting such as obesity, diabetes, due to poor diets being provided to their children, which are more than often high in sugars, salt and fats. Not encouraging the child to get exercise by driving them often a short distance of under a mile to school, can, with a poor diet, allow the onset of obesity with ensuing other health issues. These are amongst the health issues such as parents smoking in the presence of their children, that many parents need to be educated on to ensure their child has the best start in life.
