ROAD TRAFFIC REGULATION ACT 1984

THE KENT COUNTY COUNCIL, acting as local traffic authority and in exercise of its powers under Sections 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the Act of 1984) as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby intends to make the following Order.

REVOCATION, MODIFICATION AND AMENDMENTS

The "Kent County Council (Various Roads, The District of Shepway) (20mph, 30mph, 40mph, 50mph Speed Limits and Derestricted Roads) Consolidation Order 2012" be amended as follows.

In the Schedule 4 (40mph) of the Order the following shall be added from the Table below.

Item No	Road Name	Parish	Description
12	Dover Hill	FOLKESTONE	From a point 115 metres east of the roundabout junction with Hill Road, to the junction with Crete Road East.
13	New Dover Road	FOLKESTONE	From the junction with Crete Road East to a point 6 metres east of the boundary of no.18 New Dover Road (District boundary).
