Fraud

Be aware of scams.

- Fake websites will often include text that suggests a sense of urgency.
- They are often poorly designed or only have one well-designed page.
- Pop-up windows are commonly used to gather your information.
- Don't trust information that does not come from official sources.
- If a website asks you to fill in your personal or financial information, think twice before doing so.
- Research before donating to charities.
- Use a browser that allows you to block pop-up windows.
- If someone calls stating to be from any authority or your bank, they will never ask for your pin number during the phone call.
