5. **MATTERS ARISING FROM MINUTES OF LAST MEETING**

a) **Traffic Management**

**Highway Improvement Plan**

Traffic survey results now accessed by Kent Highways.

Kent Highways stated: "Capel Street surveys were accessed as "very poor", but is not an accident hotspot and flashing signs are very expensive. They investigated the crash data for the last three years (up to 31/12/2020) and there are no reported incidents and therefore it does not meet the criteria for a flashing sign".

*Action/Resolution: Decisions still under discussion for costings and include;*

- *The Councillors considered the above and excessive speeding data from surveys and feel there is now a need to improve on the latest suggestions from Kent Highway of; 20mph repeater signs at a height of 2.1m; and slow markings with additional road markings (dragon's teeth);*
- *Other option requested and to be considered, is a reduction in carriageway width in short sections with priority from one direction as seen on Stone Street from Newingreen to Lympne or on Park Farm Road, Folkestone (not necessarily with humps) costs permitting.*
- *Further 20mph roundels in the side roads where they junction with the B2011.*
- *Speed surveys on B2011 were disappointing in being assessed from "acceptable to good". Further traffic management to be investigated again in future.*
- *Parish Council funding will be considered accordingly for all above.*

**Dover Hill traffic improvement works:**

Phase 1 works at top of hill, new crossing etc., completed.

Phase 2, to alter the single file position, new signage and arrester bed works still to be carried out – date still unknown.

First Aid training for children at Primary School, agreed to be funded by Council.

	<b>Incident on 21st April 2021, of the youths setting fire to the top area of the Skate-park. Councillors requested to give views on what the Parish Council are looking for from the Police to progress this, if possible that the vandals are recognised and traced.</b>
√	Whatever needs to be done to bring these vandals to court, I am all for. Too many kids running riot now. This is the trouble today too soft on these kids. They need a short sharp shock. No good reasoning with them they will have any excuse. I am upset at all the knife crime going on with adult men being knifed by teenagers and killed. I know this is not in Capel but this is the way life is going if nothing is done to deter.
√	The outcome will be much be dependent on his age and previous offences. I believe anti-social behaviour order, compensation and a letter of apology. If under 18 normal, then give warnings and referral to youth offending team. I doubt if under 18 and 1st offence would be a criminal record.
√	Who did the damage should be caught and made to pay for the repairs.
√	In an ideal world the PC would at least get the £400 excess back from the two lads. Perhaps they might get a 'stay away' order to keep them out of the village in future.
√	If the two concerned are caught, then I think an anti-social behaviour order would be appropriate. You would need to discuss how the compensation mechanism works. If it involves the PC taking the families to court, we will need to investigate the costs involved. However, the insurance company may be able to pursue compensation, but I think we need to be guided, by the police, as to the most effective course of action.
√	Really difficult one this because what you feel should happen, cannot for whatever reason! I do think that the person responsible for this unnecessary damage should be made to understand the seriousness of what they have done, the fact it has impacted on others both financially and taking away the pleasure the area provides. Meeting the young people who have had their recreation curtailed because of the action could be unnerving and a real learning curve. They would say it how it is and there is nothing like peer pressure. No doubt the officer will tell you what could possibly happen. It all depends on whether this is a first offence or are there a string of them. Not terribly helpful I'm afraid!
√	I think that we have sufficient agreements to go ahead.

	<b>Enquiry From Resident: Does the Council think it's time to remind these Spitfire pilots of their promise to fly over the sea and not the village?</b>
X	I love to see them and hear the noise.
X	Personally, I think it's great the see the spitfires. To my untrained eye they approach from Hawkinge and over the cliff but understand the points being made. In all due respect, we have had some very challenging times over the past year and I'm sure the majority of parishioners love to see the spitfires in the sky.
X	They are lovely to hear and see fly by! I would say the majority of parishioners would not have a problem with them. I don't think we need to speak to them.
X	The spitfires should fly over every day. I love seeing them. As a child when my mother allowed me in the garden, I liked nothing more than watching them take off and land, hoping none had been shot down. I lost two uncles, shot down in spitfires.
X	I leave it up to you whether or not you share my comments with the other Councillors.
X	I have noticed this year that they often taken a slightly different flight path when approaching and tending to fly in at a higher level. Generally, they fly in from the Hawkinge direction and start to turn towards the Battle of Britain Memorial Site as they approach. When overhead, I estimate they are somewhere between New Dover Road and the Valiant Sailor. On their return, they fly a curving path back over us, around the perimeter of Capel before heading back in the Hawkinge direction. I have not observed them flying directly over the centre of Capel. I, like many others love the sound of the Spitfire, the reaction of visitors to Battle of Britain when they fly over, is always a pleasure to witness. I can't argue regarding pollution issues, but no comparison to the pollution from number cars that pass daily. However, when I see two Spitfires approaching from Hawkinge I do worry about their close formation flying as they turn in towards the Battle of Britain. On their return they are generally further apart.
X	Personally, I love to see the Spitfires. They always fly in over the Battle of Britain Memorial Site from Hawkinge so do not come over the whole village. I realise there are safety issues after the Shoreham crash, but they are not flying low and doing stunts. I think cars on our roads are a far greater pollution problem than these planes pose.
X	Perhaps we could resident to keep a log of dates and times so that we can put the issue into some perspective. A far greater noise issue is loud motorbikes which can be heard almost any time day and night all over the village and must be a particular nuisance to those living on NDR and roads off.
