Highway Improvement Plan, Virtual Meeting held on Tuesday, 11th April 2023

Present:

Kent Highways: Lezanne César - Community and Engagement Team Leader (Dover and Thanet).

Parish Councillors: Keith Pilcher and Philippa Seager, together with Parish Clerk.

The meeting, held via Teams online, on 11th April 2023, with Kent Highways, progressed the items on Capelle-Ferne Highway Improvement Plan (HIP).

All priorities on the Plan (HIP) were discussed fully, with the following **Actions/Resolutions:**

Priority 1

Speed limit 30mph outside Greenview Nursery, but only 20mph outside Capel Primary School.

Actions/Resolutions:

This priority was now resolved, with the following carried out; 30mph road roundels refreshed; Slow markings on road refreshed; School warning sign reinstated.

Priority 2

Installation of footways, in Capel Street located North of Primary school.

Actions/Resolutions:

- Lezanne (Highways), to provide location of where boundaries are for footpaths/highway and which is Kent Highway owned land, School to Winehouse Lane.
- ➤ Pending planning application 107-127 Capel Street, will be monitored until application is progressed further.

Priority 3

Double yellow lines at all junctions connecting to B2011.

Actions/Resolutions:

- Length deemed by Highways for "corner protection" double lines, is a minimum of 10 metres.
- ➤ On checking projects in other areas, lines across driveways seemed to happen. Lezanne (Highways), to clarify the lines across driveways position.
- More than 6 objections received from public would result in more administration charges on Traffic Regulation Order (TRO) application. This could make the project a non-cost effective one.
- > Parish Council to send out a further consultation letter to reflect above and provide further feedback accordingly.

Priority 4

Vehicles still speeding through the village. Installation of Speed Indicator Devices in Capel Street and New Dover Road (B2011).

Actions/Resolutions:

Lezanne (Highways), will find out more information on exactly what Kent Highway's reasoning is behind the response, that the devices are not used in 20mph zones.

Priority 5

Victoria Road, Lancaster Avenue and Alexandra Road - request of drop kerbs for mobility access. This is for route from B2011 to Village amenities at Playing Field and Village Hall, (both in Lancaster Avenue) and Primary School in Capel Street.

Actions/Resolutions:

- ➤ Online location undertaken as to the position dropped kerbs required. After ascertaining and noting these, the following was determined; 2 pairs of dropped kerbs at junction Victoria/Alexandra Road; 2 pairs of dropped kerbs in Lancaster Avenue; 2 pairs of dropped kerbs at junction Avondale/Beatrice Road.
- ➤ Cost implications of approximately £1,000 per pair (Total £6,000), with Kent Highways contribution of providing one of the pairs. Cost to Parish Council approximately £5,000.
- Lezanne (Highways), to take this project suggestion to the Highways Planning and Advice Team.

Summary

Kent Highways and Parish Council to make more determined decisions of what type of Traffic Management can be implemented and the costings for these, which will depend on financial constraints.

Dear Sir/Madam,

Capel Parish Council recently published an intention to consider applying for a Traffic Regulation Order (TRO), for Double Yellow Lines to be installed on side roads where they meet New Dover Road.

The feedback from Capel residents indicated that many were in favour of double yellow lines, but some residents voiced concerns about the lines being 50 metres in length, so preventing them parking in front of their property.

On Tuesday the 11th April, the Parish Council's Highways Improvement Plan working party had a virtual meeting with Kent County Council (KCC) Highways.

KCC referred to the double yellow lines at the junctions as, "Corner Protection", the lines would be 10 metres in length from the junction (*just over 2 car lengths*) and not 50 metres as previously stated.

Whilst the Parish Council appreciate that in some cases the lines may cross residents' driveways, but on balance, feel that the introduction of the lines would improve road safety at the junctions.

However, KCC Highways would need to carry out a survey of each junction to determine whether Double Yellow Lines would be suitable.

Once again, the Parish Council would welcome your views on this subject.
