Good morning, thank you for your email.

The Major patching that was initially planned has been cancelled due to budgetary constraints, as many other roads in the district. The road will receive its planned statutory duty inspections and when defects along this road meet the inspection criteria for intervention, they will receive repairs.

I have also checked out systems and the road is with the Roads and Footways Asset Team and is highlighted as a District priority from the Operations Team (ourselves) but this will be risk assessed and planned accordingly by them. The road is simply too large of an area to be resurfaced by the Ops team and this is why it has been passed to RaFAT to carry out works.

I understand this could be quite frustrating for the Parish however, I will do all I can in my power to ensure this is prioritised.
