Lack of adequate Street Lighting, various locations, Old Dover Road

Ownership of some land and verges on Old Dover Road undefined.

An approximate cost of installation for one (1) lighting column was quoted as £10,000, (supply, installation and connection to nearby source).

As no safety issues have been evidenced in the location, would not be something Kent Highway would address. Advice sought on what else could be done. To make contact with KCC Street Lighting Team for further information.

Additional drop-kerbs in Beatrice Road, junction with Alexandra Road

Having located area on Map, Lezanne would request KCC Design Team, to provide costings.

Speed Indicator Devices on New Dover Road

Toby Butler, KCC, Highways & Transportation, Traffic Operations and Technology Manager. Following engineer's assessment of location, Lezanne to chase on positionings and costings.

Retro fit of tactile paving Beatrice Road, near to Lancaster Avenue/Avondale Road

Still with Highway Design Team.

Concern expressed on time delay on this issue.

Junction Cauldham Lane/Capel Street/New Dover Road (B2011)

• Cllr. Alfsdotter asked the question regarding the dangerous issue with this junction. This will be heightened, with the 4 development sites of 149 additional properties planned, using this area. i.e. (16 + 9) 25 in Cauldham Lane, 90 rear of Capel Street and 34 at 107-127 Capel Street.

Could there be a change in layout, by dividing the junction and forming a new one?

- > existing junction for use/access to Cauldham Lane/Close and beyond (farmland etc).
- block turn-off to Capel Street and
- ➤ form a new junction to/from B2011, on grass triangle top Capel Street, for additional traffic the Capel Street developments will create.
- KCC, Thomas Williams, informed the meeting that a Notice was being issued to 2 Cauldham Lane on repositioning fence.

Both members of KCC present indicated this was beyond their remit.

As it would be a major change of layout, their advice was, to log another letter with Dover District Council Planning Department, against and naming, all four (4) developments in the area and the concerns the additional traffic they will generate on this junction.

This addressed, as the responsibilty, jointly, of the Developers in question. accentuating a "goodwill gesture" to provide for the safety of local residents and visitors.

Cllr Martin Hibbert- Annual Summary Ward Report 2025

Over the last year my work has continued focusing on building good networking between my ward Parish Councils, their communities, and individual residents. This work is at the top of my agenda and is always work in progress.

To help with this progress over the last months I have endeavoured to provide a general ward councillor monthly summary report. The report covers DDC actions and topics which have the potential to influence or impact on the individual PCs agenda items for discussion and resolution. Topics such TAP, European Entry and Exit system, Dover Fast Track and Quality Bus Partnership, just to name a few. Coupled with this I have forwarded DDC and KCC published information which is pertinent and useful to my ward communities which is not always easily obtainable. I believe this approach helps to deliver more informed decisions and more positive results benefiting our local communities.

Also, over the last year, it has been good to witness ward councils sharing information on common community projects such as playgrounds, highway improvement plans, building development concerns, and mutual community activities. Visible proof that councils are working collaboratively together building stronger councils that are listening to their respective communities to serve and help deliver their needs.

Capel PC has focused on again delivering for their community this year. Much work has been done in the resolved various working parties towards achieving that goal. It is good to see councillors being active, engaged and committed to serve and getting involved with local issues and community work. This has seen work being done on the Capel playground bringing about refurbishment and improved facilities. Much attention this past year and ongoing is the challenges being brought about by various large housing planning permissions being granted within the village, and the impact on the residents. Capel PC has been in the forefront in supporting villagers' concerns going forward. They have been supported in this task by both me and Cllr Beaney acting as advocates on their behalf. TAP when initiated still brings traffic congestion problems to the village. It is hoped that the promised new diversion signage will soon be installed to help mitigate against this perennial problem.

The flooding that severely impacted on villagers in Nov 23 has seen the National Flood Forum supporting and representing those people at flood risk. Several meetings have taken place and a new flood action plan is being developed to help future proof against this risk. Much praise must go to the impacted villagers who have worked collaboratively with the Flood Forum team and Capel councillor towards shaping this plan. Well done to all involved.

It is still work in progress for the Capel HIP bringing about safer roadways wherever they can. Overall, am pleased to support and help a hardworking and committed Parish Council. My job will remain the same – to ensure that Capel and the interests of my ward communities are fully represented and best served, and I will continue to work hard to get things done on your behalf.
