<u>PRESENT</u>: Cllrs; Alfsdotter, Harris, Lake, Leppard, Norris, S Pilcher, Seager and Young, together with District Councillor Martin Hibbert and Kent County Council Community Warden Jan Henry.

1. <u>APOLOGIES</u> - Cllr. K Pilcher, Kent County Council Ward Councillor Paul King and Parish Clerk Maureen Leppard.

2. <u>DECLARATION OF PERSONAL INTERESTS:</u>

Cllr. Young declared an interest in Agenda item number 10.

3. PUBLIC ADDRESS TO COUNCILLORS, FEEDBACK FROM COUNCIL SURGERY and OTHER SOURCES

Public addressing the members, should be on this agenda item only and not during other discussions of the meeting. Items raised are discussed by Councillors under related entries on Agenda.

- Residents requested an additional bus shelter by Alexandra Road. Seat in shelter at Winehouse Lane.
- Cut back of hedges on New Dover Road.
- ➤ Bonfires at Lighthouse Inn.
- Abandoned caravan and fly tipping Old Dover Road. (Now removed).

4. <u>MINUTES OF THE MEETING</u>

Speed Watch have requested that they be known as Kent Eastern Region (KER) Speed Watch in the minutes in future.

<u>The Minutes of the Meeting</u> held 17th June 2025, were then approved and signed as a correct record by Chairperson, Cllr Seager, proposed by Cllr. S Pilcher, seconded by Cllr. Norris, agreed by all present.

5. MATTERS ARISING NOT COVERED ELSEWHERE ON AGENDA

a) Flooding – Capel Street/Lancaster Avenue.

Cllr Norris has carried out an inspection of the chambers. Still no response from Kent County Council. There is a meeting on 23rd September of the Flood Forum but Cllr Norris would like a premeeting on 26th August. Evidence of recent flooding in June has been recorded. *Action/Resolution:* To approach the Association of Local Council for advice. District Cllr Hibbert asked to be informed if help is needed. Cllr Paul King to be chased for an update on this matter.

- b) Clifftop Land (Gifted in Will) Action/Resolution: Ongoing. Still no progress with solicitors. Grass still being cut.
- c) <u>Health and Safety documents and Risk Assessments</u> *Action/Resolution: Difficulty with Clerk's change of email address.*
- d) Other

Street pole damaged, is in hand with UK Power Networks.

<u>Pot holes in Hurst Lane</u>. Still chasing after two months, the PC would like an update as this is being paid by taxpayers. *Action/Resolution: Get the Contractors back as there is a latent defect. Passed to Cllr King as he is now the Kent County Council cabinet member for "Economic Development and Coastal regeneration. Copy in District Cllr Hibbert.*

6. **PLANNING**

- a) Applications: Status of all pending applications, circulated and attached to minutes.
- b) Other Capel Court Park waiting Appeal Application to Government Inspectorate, on refusal decision by Dover District Council on Certificate of Lawfulness. *Action/Resolution: The residents are having a meeting in November and Cllr Lake raised concerns and says the PC should support the residents.*

7. <u>DELEGATES' REPORTS</u>

- a) Neighbourhood Watch Community Warden reported
 - ➤ Police involvement with victimised resident. PC Ellis has been informed.
 - ➤ Police were involved in death of elderly resident. Concerns were raised about the dog left in the home. The RSPCA visited and left the dog overnight with food and water and collected the dog the next day for re-homing.
 - ➤ Water leak Capel Street, still under investigations.

b) CCTV/ICT

- Request for CCTV footage from the Village Hall Management Committee. *Action/Resolution:*After discussing the legality, passing of responsibility, following guidelines from Information

 Commissioner Office (ICO), and with the required paperwork deemed in place, the PC agreed to release CCTV footage of an incident at Village Hall.
- Discussion on the possible purchase/update of some of the CCTV cameras. *Action/Resolution:* To be investigated. Proposed by Cllr Lake, seconded by Cllr Harris and agreed by all.

c) Play equipment

Annual Royal Society for the Prevention of Accidents (RoSPA) inspection of recreation equipment, carried out in July. Waiting reports.

d) Highways and Traffic Management

- Highway Improvement Plan (HIP)
 - Lights on Old Dover Road Cllr Lake asked if there was any change in the lighting in ODR. Still long sections without light. Action/Resolution: The PC decide to leave as it is now, but put on the agenda in October when the clocks change.
 - ➤ <u>Vehicle activated signs on New Dover Road (B2011)</u> *Action/Resolution: Still waiting for the design. The info was sent to Cllr King. A meeting was requested but no response.*
 - Additional tactile paved drop kerb, Beatrice Road. Action/Resolution: Waiting Kent County Council Highways design team on cost.
 - ➤ <u>Provision of diversion signage M20/A20</u>, when Roundhill Tunnels closed. Action/Resolution: Nothing since December. District Cllr Hibbert says it is still ongoing and will chase. No update at present.
 - Lut back to hedge in Capel Street ongoing. Action/Resolution: Work completed.

e) Public Rights of Way

- ➤ Cllr Lake has written to Kent County Council regarding cycling along the cliff top, especially in the recent high winds. *Action/Resolution: Can we use the existing way-marker signs for no cycling signage?*
- There are two wooden signposts broken and out of use. Rear of the church and Green Lane *Action/Resolution: Need replacing.*

f) Kent Eastern Region (KER) Speed Watch

Report given by Cllr. S Pilcher (attached to minutes), on 4 sessions, 20th June to 4th July. 16 offenders. 3 out of 9 on Old Dover Road speeding and a black Jaguar now tops the chart at over 50mph. *Action/Resolution: Could the Chart leader be published?*

g) Events

80th VJ Day Celebrations (Friday, 15th August 2025)

Everything is in hand for VJ Day. Cllr. Seager has organised the flags, bunting and serviettes. The cake is ordered and Capel Cares are doing everything else.

Afternoon Tea (Saturday, 18th October 2025)

With approximately 60 residents to be invited, it was felt that at £20 per head, would be too expensive. Giving vouchers was discussed. *Action/Resolution: Cllr Leppard said that Folkestone Bowls Club do cream teas at about £12 per head.*

Poppy Tableau

As the tableau will have over 3000 poppies on it, the group have outgrown the small room in the Village Hall and need to move to the small hall. This will be charged at £8 per hour. One and a half hours sessions at £12. Cllr Seager has already booked the next three and asked for a further 5 sessions required. The cost will be £96. Action/Resolution: The PC decided to cover this cost, proposed by Cllr. Lake and seconded by Cllr. S Pilcher and agreed by all present. Cllr. Seager will ask the VHMC if the tableau can go out on Farmers' Market Day, if space is available.

h) Capel Cares

The group are going to be involved with VJ Day.

They have 40-45 residents each time and the cakes will be discussed at the next meeting. Kent Award application, update in September required.

- ➤ The Xmas Tree lighting will be on 12th December.

k) Training/workshops/seminars

Cllrs. Seager and S Pilcher recently attended a Devolution Conference. With 300 people and reported:

- We are described as 'Poor Kent.'
- Still nothing definite on numbers, it could be two areas or up to 5.
- If it is smaller areas we could align with other parishes. It would give us more weight.
- Both Cllrs came way worried at the outcome.

1) District and County Councillor Reports

- ➤ District Councillor Martin Hibbert
- Cllr Hibbert stated that no one seems to know where they will be in the Devolution. He promised to keep the PC informed.
- With the new Planning and Infrastructure bill decisions will be handed down, not local. Decisions will be taken away from parishioners.
- The new Entry/Exit System is due to come in force in October. DDC have asked Port of Dover for a presentation.
- Operation Brock is now in force as it is the start of the summer holidays.

County Councillor Paul King:

m) Other

- Community Warden Jan Hendry stated that at the end of Old Dover Road, a tent had been dumped. As this is private land no further action will be taken.
- ➤ District and County Councillors' report. The PC have decided to ask District Cllr. Hibbert and County Cllr. King, to submit their reports in advance of the meetings in future so Parish Councillors can discuss.
